## IV. Discipline

- A. David Bialik David Bialik appeared in a return to practice capacity. David Schaibley explained the past settlement agreement which required the licensee to appear in person before the board before returning to practice. Mr. Bialik presented his CE credits that were required and engaged in the required counseling required by the board. His satisfactory progress reports were received and he completed his fitness evaluation as required. David Bialik's statements at the meeting included his understanding of what transpired, what he's learned, and how he will implement safeguards to ensure the situation will not occur again. He expressed remorse for the situation and expressed that he exercised bad judgment that resulted in boundary violations. He explained that he would like to return to doing good things. He plans on continuing his self-care work and plans on keeping his practice limited to telehealth during the initial period to keep some separation between the clients and Mr. Bialik. David Schaibley explained that Bialik said that he would need to reapply for licensure, but they can make a motion to lift the suspension and allow him to reapply or can push this down the road to the next meeting. Ultimately, Lacey moved to allow him to reapply for licensure, and Melissa Waind seconded the motion. It was passed in a 6-0-1 vote (Holly Hammarsten was absent).
- B. Toni McCarty This licensee was placed on probation and had requirements including a 2-page report on boundaries and to submit proof of 2 CEs regarding boundaries. Administrator Feldner explained that the proof of the CE included someone else's name when a readable copy was included, not the licensee's name. The Board said they would like verification of the evidence that she completed the credits as required by her settlement agreement. She is still practicing as she is on probation, not suspension.

## V. Policy Discussion

- A. Legislation
  - SB 2203 The Board reviewed this bill and the draft testimony as drafted by Jennifer Boeckel. Rhonda Allery suggested that the Board member that delivers the testimony should submit it the night before and plan on spending the day at the Capitol. Lacey Corneliusen moved to upload the testimony and Jennifer Boeckel seconded the motion. It passed in a 6-0-1 vote (Holly Hammarsten absent.) Administrator Feldner will complete final formatting and submit the written testimony to the Workforce

Development committee. The members of NASW offered to help moot the testimony questions. The committee will decide who is testifying after the hearing is scheduled.

- 2. HB 1332 The Board reviewed an email received on this bill from NASW, who testified in-person and submitted written testimony.
- 3. HB 1416 Any willing provider Administrator Felder gave a synopsis of the bill and explained that the sponsor was still looking for support after crossover.
- 4. SB 2184 The discussion about this bill surrounded the likely hoghouse and they decided to watch the proceedings and monitor the issue.
- B. CE Broker The board discussed a participating addendum for CE Broker and the benefits of the software. Lacey moved and Cory Pederson seconded to enter into the addendum. The vote passed in a 6-0-1 vote and Dave Schaiabley will work on the paperwork.
- C. Electronic license verification from other states Administrator Feldner explained that some states are no longer processing paper verifications, and will instead require us to verify on their self-service website. A discussion was held and Lacey moved to allow electronic verifications of licenses in other states. The vote passed 6-0-1 (HH absent).
- VI. Executive Session Cory Pederson moved to enter executive session and Lacey seconded. The motion passed unanimously. They entered executive session at 8:21 and was adjourned at 8:50pm.
  - A. The Board made a motion on Complaint 2022-06 Rhonda moved to dismiss this complaint. Cory Pederson seconded. The motion passed unanimously in a 6-0-1 vote. (Holly was absent).
- VII. The meeting was adjourned at 8:52pm.

Where noted, the discussion of some of the above topics may be held in executive session rather than during the portion of the meeting that is open to the public. If this is a regular meeting, additional topics may be discussed. If this is a special or emergency meeting, the governing body's discussion will be limited to the topics and executive sessions listed above.
